

# PRIVACY STATEMENT

## **Introductory Provisions**

On this page, you will find the privacy statement of Leenders Haardkachels B.V. (hereinafter: Leenders). You are advised to read this privacy statement carefully. Leenders is legally established at Industrieweg 25, 5688 DP, Oirschot, and is registered with the Chamber of Commerce under number 17045218. Leenders can be contacted via email at info@leenders.nl.

This privacy statement explains how Leenders handles the processing of personal data. It specifies which (categories of) personal data are collected and the purpose of their use. Leenders also indicates the legal basis for processing personal data.

The processing of personal data by Leenders falls within the statutory exemption regulations. Therefore, the processing has not been reported to the Dutch Data Protection Authority.

Leenders reserves the right to amend this privacy statement. The current privacy statement was last updated on 26-02-2025.

## Types, Purposes, Legal Grounds, and Retention Period of Personal Data Processing

Firstly, personal data is processed when you enter into an agreement with Leenders. The personal data is used to contact customers. The form specifies which data fields are mandatory. These include all data related to an identified or identifiable natural person, such as email addresses, names, phone numbers, personal photos, and IP addresses. It may also include a list of orders or visited websites. Your email address is also requested via the form. This email address is necessary for contact purposes and to keep you informed about products or services that may be of interest to you.

Personal data is stored for a period of five (5) years.

## **Legal Basis**

The processing of your data is based on the following legal ground: the consent of the individual/visitor is necessary for the processing of personal data. This consent is important for contacting customers.

## **Personal Data Collected Physically**

Leenders also collects personal data obtained physically during a meeting, an introductory conversation, or when signing an agreement. This concerns the same data as mentioned in the previous paragraph. The collection of this personal data is based on the same legal ground. By providing this data, you also agree to this privacy statement.

#### Cookies

Leenders uses cookies on its website. What are cookies? A cookie is a piece of data that a website places on your computer. Each time you visit the Leenders website, basic technical information is collected, such as the website that directed you to this site. This privacy statement applies to cookies and similar technologies. This website may use cookies to provide visitors with customized information, collect information, and track visitors during their visit to the website. This helps Leenders deliver a good user experience.

#### **Links to Other Websites**

This privacy statement applies only to this website and the data collected through an introductory conversation following a visit to the website. This website may contain links to other websites that are not managed or owned by Leenders. If you click on such a link and navigate to another website, the privacy statement of that website applies. Leenders is not in any way responsible or liable for these websites or their privacy policies. Leenders advises you to read their privacy statements carefully before continuing on those websites.

## **Transfer to Processors and Third Parties**

Personal data is processed by companies engaged by Leenders for the execution of the agreement. The law refers to these companies as 'processors.' These may include, for example, the company that hosts the Leenders website or a printing company. If you have questions about who these processors are and where they are located, you can contact Leenders. The processors operate under Leenders' responsibility. Your personal data may also be shared with third parties if Leenders is legally obliged to provide your personal data to authorized authorities.

## Security

Leenders has taken appropriate technical and organizational measures to protect your personal data against loss or unlawful processing. The website has an SSL certificate, ensuring that data is transmitted over a secure connection.
